

# Raffle for iPad 2 and Daytona 500 Hospitality Packages

## Contest Rules 2011

### CONTEST ELIGIBILITY

- A ticket represents a chance to win either an iPad2 or 1 of 2 Daytona 500 Hospitality Packages.
- You must be 18 years of age or older to purchase a ticket and qualify under Oklahoma law.
- No multi-party ticket entries are allowed.
- The ticket stub must be completed with the name, phone number and email address of the contributor.
- Raffle tickets are non-transferable and non-refundable.
- All ticket sales are final.
- Tickets are issued only to individuals based on a donation to Keep Oklahoma Beautiful.
- This contest is subject to all applicable federal, state, and local laws and regulations. It is void where prohibited by law.

### ODDS OF WINNING

- There will be no more than 2,000 (two thousand) tickets given out for the Daytona 500 raffle and no more than 500 tickets for the iPad 2 raffle.
- 1 (one) iPad 2 Raffle Ticket will be given to a donor who makes a donation of \$10 to Keep Oklahoma Beautiful. 6 (six) tickets will be given to a donor for every \$50 donated to Keep Oklahoma Beautiful. Each ticket will be entered into the drawing separately and have its own unique ticket number.
- 1 (one) Daytona 500 Raffle Ticket will be given away to a donor who makes a donation of \$25 to Keep Oklahoma Beautiful. 5 (five) tickets will be given to a donor for every \$100 donated to Keep Oklahoma Beautiful. Each ticket will be entered into the drawing separately and have its own unique ticket number.
- Each ticket has a separate and equal chance to win each prize.
- The winning ticket will be selected at random and all participants have an equal opportunity to win.
- There is no possibility of a tie in this raffle.

### DRAWING INFORMATION

- **The drawing will be held in the evening on November 10, 2011 at the Skirvin Hilton Hotel during the Keep Oklahoma Beautiful 21<sup>st</sup> Annual Environmental Excellence Awards Celebration.**
- At the drawing, five ticket stubs will be drawn from the raffle box by the Banquet Emcee under the supervision of the Keep Oklahoma Beautiful Executive Director and Board President. Those tickets will be assigned a number from one through five according to the order they were drawn. Should the winner fail to claim the ticket, the #2 ticket holder shall be deemed the winner and so on until the prize is claimed.

### **NOTIFICATION OF WINNER**

- Winners need not be present to win.
- The winner will be notified by telephone and email within 48 hours of the drawing at the telephone number and email address provided on the purchased raffle ticket. The winner's name will also be posted on this website within 48 hours of the drawing.
- The winner must be at least 18 years of age and be a legal U.S. citizen.
- The winner has 14 (fourteen) days to take delivery of the prize, or will forfeit all claims thereto, with no substitution or alternative prize available.
- However, the winner may have up to 30 (thirty) calendar days of the drawing date to finalize the process (including payment of taxes, withholding, etc).
- The winner's name, hometown, and photo may be printed in select media and on this website.

### **TAXES AND IRS RULES**

- The winner is subject to any and all federal, state, and local income taxes and other taxes due to their acceptance of each prize and the law, regulations, procedures, rules, and directives applicable to raffles.
